1. Activities undertaken during reporting period

The Future Greens project has been actively working to bring new opportunities to Warsop Parish through building relationships and accessing new funding.

- In order to access Miner to Major funding and deliver training through Inspire, it was necessary for Andy Hollis (AH) to become a Freelance instructor for Inspire. This has now happened and AH developed a series of short courses for the Spring term, which started in January 2021 and ended in March 2021. Unfortunately, these courses were cancelled due to lockdown restrictions. In addition to this AH has now developed a series of courses for the Summer term and these courses will commence in April 2021. These courses are now live and can be observed and booked on through the Inspire website. https://www.inspireculture.org.uk/skills-learning/miner-2-major-courses/ This new relationship with the Major to Miner programme will fund the development of short bespoke courses for Warsop Parish.
- Courses in Warsop include; INTRODUCTION TO PLANT PROPAGATION GROWING WILDFLOWERS, INTRO TO RIGHTS OF WAY - FOOTPATH MAINTENANCE, EXPLORING THE OUTDOORS; SKILLS TO HELP YOU SURVIVE OUTDOORS, NATURE WALKS, and TREE IDENTIFICATION
- AH has negotiated to deliver Level 1 courses in Conservation skills and Growing plants.





- I have become a freelance instructor for the Academy Transformation Trust Further Education,
 which allows access to an established horticulture unit on the site at Ollerton. This will allow us to
 offer further courses, which will be available to residents in Warsop and there is potential to
 develop a range of courses operating from this site and also at Warsop once the Meden site is
 operable.
- I have secured a landscape maintenance contract at Ransomwood which will allow me to develop
 opportunities for work experience within the context of providing contractual services within the
 land based and environmental sector.
- We are investigating the opportunity to utilise the government kickstart scheme to provide opportunity for long term unemployed.
- I have continued to liaise with Mansfield District Council and Meden School, through the Partnership agreement with Vibrant Warsop, with regards to the planning application for the Meden School Environmental and Horticultural training facility.
- I have researched the purchase of a minibus and have now secured a vehicle,14 Seater Ford Transit Minibus. This vehicle will be collected once covid restrictions ease.
- I have supported Meden School with advice on the purchase of fruit trees for the NHS Hope Orchard initiative, and will support the planting of these trees on 22nd March 2021.

2. Target Outcomes the project has contributed to

Despite covid restrictions I have now developed a range of opportunities for local people as identified in the target outcomes. These will now be delivered and built upon and it is intended to access funding and other resources through the Miner to Major programme for the next 3 years, whilst developing other opportunities in addition to this revenue stream.

The project has been set back through restrictions due to the National pandemic, but a considerable amount of work has been undertaken to ensure that this work can now commence and continue once restrictions are lifted.

We intend to start delivering training from April 2021 and build on the work that has already been done, in anticipation of this continuing.

It is also intended to offer more accredited training both through Inspire and also independently of this revenue stream. When we access the plot of land at Meden school, we will offer a Level 1 in Horticulture, and provide opportunities for volunteering with the external funding that was secured before the start of the pandemic
